

The Glen Elder City Council met in special session on Wednesday night at 7:00 p.m., December 30th, 2015 at City Hall, with Mayor Ryan Duskie presiding and council members Sheila Paxson, Lindsey Clark, Barry McPeak, Tracy Anderes and Ken Kusler present. Also in attendance City Attorney Katie Schroeder and Clerk Jerri Senger.

Daycare

Be it resolved that the governing body of the City of Glen Elder, Kansas hereby approves the sale of the property known as the Daycare as legally described as follows, to-wit:

Lot (6), Block Eight (8), Young's Addition, City of Glen Elder
To Toni Schlaefli by a vote of 5-0.

School

Be it resolved that the governing body of the City of Glen Elder, Kansas hereby approves the purchase of the property known as the Grade School building and ball fields as legally described as follows, to-wit:

The South 35 feet beginning 366 feet East and 250 feet North of the point of the center of County Road Number 90 at the Southwest corner of the Southeast Quarter of the Northeast Quarter (SE1/4 NE1/4) of Section Twenty-seven (27), Township Six (6) South, Range Nine (9) West of the 6th P.M.; thence East 183 feet; thence North 100 feet; thence West 183 feet; thence South to the place of beginning, except the West 33 feet used for a public street in the City of Glen Elder, Kansas,

AND

Beginning 366 feet East and 100 feet North of a point in the center of County Road 90, at the Southwest corner of the Southeast Quarter of the Northeast Quarter (SE1/4 NE1/4) of Section Twenty-seven (27), Township Six (6) South, Range Nine (9) West of 6th P.M.; thence East 183 feet; thence West 183 feet; thence South 150 feet to the place of beginning; and further known and described as Tract Number 22, and located in the City of Glen Elder, Kansas,

AND

Beginning at a stone (marked with a cross in the top) on the south line of the Southeast Quarter of the Northeast Quarter (SE1/4 NE1/4) of Section Twenty-seven (27), Township Six (6) South, Range Nine (9) West of the 6th P.M., said stone being 37 and 7/10ths rods West of the quarter corner on the East line of said Section 27 (see deed from J.H. Allen to W.L. Allen in Book X, page 185, in Register of Deeds office in Beloit, Kansas) and 300 and 7/10ths feet East of the East line of Nash Avenue; thence West along the South line of said SE1/4 NE1/4 150 and 7/10ths feet; thence right 90°10' running North along the East line of Porters Addition, 471 and 4/10ths feet to a stone marked with a cross in top; thence right 90°1' running East 325 feet; thence in a Northeasterly and Easterly direction down the center of Limestone Creek, to the East line of said Section 27; thence South along the section line about 280 feet to the corner of a tract of land owned by W.L. Allen, beginning 27 and 1/8th rods North of the quarter corner on said section line; thence right 54°55', running in a Southeasterly direction 761 feet to the place of beginning.

Purchase approved by a vote of 5-0.
