### ORDINANCE NO. 711

AN ORDINANCE RELATING TO THE VACATION OF A PORTION OF NORTH MILL STREET AND WEST 2<sup>ND</sup> STREET IN THE CITY OF GLEN ELDER, MITCHELL COUNTY, KANSAS, PURSUANT TO K.S.A. 15-427, CORRECTING THE LEGAL DESCRIPTION IN ORDINANCE 709 AND REPEALING ORDINANCE 709.

#### **BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GLEN ELDER, KANSAS:**

SECTION 1: That the Governing Body of the City of Glen Elder, Kansas deems it expedient that a portion of **North Mill Street** in the City of Glen Elder, Mitchell County, Kansas be vacated, to-wit:

A platted north/south street known as North Mill Street lying east of Lots 1-4, Block 4, Allen's Addition, including that portion of North Mill Street lying south of Block 1, Allen's Addition and east of the previously vacated portion of West 2<sup>nd</sup> Street, City of Glen Elder, Kansas.

The above described street shall be and is vacated except for reservation of the City of Glen Elder for the right to install, repair, maintain, alter and operate sewers, storm drains, water mains, utility poles, underground electric lines and cable lines for franchisees of the City, and other utility services into, upon, over, across and under the above described tract and the right to keep the same free from foliage. The vacated portion shall revert to the owners of real estate thereto adjacent on each side in proportion to the frontage of such real estate.

SECTION 2: That the Governing Body of the City of Glen Elder, Kansas deems it expedient that a portion of **West 2<sup>nd</sup> Street** in the City of Glen Elder, Mitchell County, Kansas be vacated, to-wit:


A platted east/west street known as West 2<sup>nd</sup> Street lying south of Lots 3 and 4, Block A, Arthur's Addition, and lying north of Lots 3 and 4, Block B, Arthur's Addition, City of Glen Elder, Kansas.

The above described street shall be and is vacated except for reservation of the City of Glen Elder for the right to install, repair, maintain, alter and operate sewers, storm drains, water mains, utility poles, underground electric lines and cable lines for franchisees of the City, and other utility services into, upon, over, across and under the above described tract and the right to keep the same free from foliage. The vacated portion shall revert to the owners of real estate thereto adjacent on each side in proportion to the frontage of such real estate.


SECTION 3: Ordinance 709 is hereby repealed.
